I am writing to you today following your expression of interest (with my colleague Tom Watkins) to include a Welcome Space Cafe into the delivery of your community services.

Communities 1st have been running the Welcome Space Project for almost 2 years now, where we offer funding for community groups across Hertfordshire to provide a welcome space.

For more information, including success stories about our current Welcome Spaces follow the link: Welcome Space Network Project August 2024 (communities1st.org.uk)

Access to this funding requires the welcome space projects to run as followed:

- one session a week
- up to 4 hours
- open access to all

The funding is intended to help with:

- Core running costs
- Refreshments (tea, coffee, soft drinks, biscuits)

You can use this funding within any activity that you currently run

As part of the project Communities 1st will also provide:

- Leaflets and literature to distribute to attendee
- Volunteer Energy Advisors to provide expert guidance and advice
- Volunteer Benefits Advisors, with one-to-one consultations available
- Numeracy, budgeting, cooking & nutrition skills workshops
- Digital Inclusion access and training
- Referral forms for support services will also be provided

Monitoring and evaluation:

This is an essential element with this project where community groups will be required to submit data through an easy-access online portal, on a weekly basis. However, should you need support with this I will be on hand to help with solutions to ensure the data is reported. Please rest assured, the data input required is minimal and should only take 5-10 minutes of your time.

The data reported to us will be used to evaluate the targets that are in place for the funding. This can be reached throughout all your centre's activities, not just the sessions that are funded.

If you have any questions, I am more than happy to visit you in-person or if you would prefer, we could meet virtually via Teams.

I look forward to your response and our potential meeting.
